Saudi Arabia effort to combat **Antimicrobial Resistance**




Saudi Arabia effort to combat Antimicrobial Resistance outbreak



Saudi Arabia is considered one of the forefront countries in the Middle East region in combating the spread of Antimicrobial Resistant in Animal health.





The Kingdom has banned the use of antimicrobials as growth promotor for livestock and poultry since 1997.



Saudi Arabia effort to combat Antimicrobial Resistance outbreak



The Livestock Law issued in 2003, emphasized the use of antimicrobials in a responsible use in animals health. This law was canceled with the issuance of the Agriculture Law issued by the Royal Decree No. (M/64), dated 24/3/2021, and its executive regulations and guidelines, which contain obvious texts to address this outbreak. The articles was based on the recommendations of competent international organizations, shedding the light on the responsible use of antimicrobials in the animal health fields.





Antimicrobail Resistance in Saudi Arabia



Saudi Arabia is one of the first countries in the region to adopt a national action plan to combat the phenomenon of Antimicrobials Resistance in animal health in 2017, and it was updated in 2021.



Saudi Arabia has cooperated with the Gulf Cooperation Council to approve a plan to respond to the resistant microbes' outbreak in the animal health field in 2023.
