

Competent Authority(ies)

Competent Authority responsible for animal welfare during transport by land and sea

 NSVFSA at central level (mainly coordinating role - instructions and guidelines, also inspections to check whether the official controls performed by local competent authorities are effective)

- 42 local CA (approval of transporters, means of transports, journeys, official controls at the place of departure, during transport, at exit points)

Other Authorities involved in cross-border transport of animals by land and sea:

- Romanian Naval Authority (CA for Port State Control)
- Romanian Border Police

Animal welfare standards

- Regulation 1/2005/EC

- National legislation for approval of transporters, vehicles and livestock vessels, protection of animals during transport to non-EU countries (Order 16/2010&Order 128/2020, Law 150/2020)

- Specific procedure (PS20) for control of animal welfare at the BIP/EP.

Road transport

Before travel: section I of the JL (48 h prior departure): correct estimation of duration (loading, unloading, average speed, resting times, border controls), contingency plan, authorization of transporter and vehicle approval, certificate of competence for the driver, fitness for travel (If unfit, either treated (minor injuries) or emergency slaughtered), space allowance, water, feed and bedding onboard, weather forecast (Checklist filled in)

Deficiencies – checklist; notified to the CA approving the transporter/vehicle



Animal welfare standards

The health certificate is issued by OV in BIP following inspection of animal health and welfare and based on the HC issued by the veterinarian at the assembly centre.

After travel:

- retrospective checks (assess whether the AW requirements were observed throughout the journey: duration, resting times, temperatures); transports selected based on risk; sections of JL compared with TRACES, GPS data and temperature recordings

Sea transport:

- notification of intention of loading 4 working days prior to arrival in EP
- valid loading permit (e.g. Libya) species, no. of animals, same importer as in accompanying documents (HC, Bill of loading, invoice)
- inspection performed by OV and maritime experts authorized by maritime authority; checklist

Actions in case of non-compliances

When OV at the BIP/EP detects deficiencies (HC or unfit animals) – rejection of livestock export; animals to be dispatched to the place of origin

If OV decides that animals are not fit for transport to the place of origin, they are unloaded at the BIP/EP facilities (watering, feeding, resting) or assembly centres close to the BIP/EP based on service agreements (with the EP administrator)

OV informs CCA accordingly

Conclusions

In order to improve animal welfare during long distance transport – new legislation:

- attempting to get transporters become more responsible, better contingency planning (representative of transporter: ISM management company);

- authorizing the maritime experts performing inspections pre-approval and pre-loading.

Main challenges for the Competent Authority to implement relevant legislation and requirements on animal transport:

- communication with CA of countries of destination (feedback at arrival of the animals);

- implementation of new EU Regulations in terms of control posts in the vicinity of Exit Points and OV on board of livestock vessels.
