## **One Health Concept**

### • OHHLEP:

 an integrated unifying approach which recognizes that the health of humans, domestic and wild animals, plants and our ecosystems are closely linked and inter-dependent.

### Collaborative Approach

 promotes multisectoral collaboration among health, veterinary, and environmental professionals for better health outcomes.

### Addressing Global Health Issues

 One Health is crucial for tackling emerging diseases, antimicrobial resistance, and food safety challenges worldwide.






# What is OH JPA?


 Is a technical document informed by evidence, best practices and guidance from the QPT.

### OH JPA scope

 Guided by the inclusive OH approach to addressing health threats at the human-animal-environment interface



# OH JPA vision



is a world better able to prevent, predict, detect and respond to health threats and improve the health of humans, animals, plants and the environment while contributing to sustainable development.



# Goal

### • Long-term outcome 1:

• Improved health of humans, animals, plants and the environment while identifying sustainable system-wide One Health solutions that allow our ecosystems to thrive in harmony.

### Long-term outcome 2:

• Reduced risk and impact of health threats at the human—animal—plant—environment interface using a One Health approach efficiently, effectively and equitably.



## Operational objectives

- ✓ Provide a framework for collective and coordinated action to mainstream the One Health approach at global, regional, national and community level to work towards the vision described above.
- ✓ Provide upstream policy and legislative advice and technical assistance to help set national targets and priorities across the sectors for the development and implementation of One Health legislation, initiatives and programmes.
- ✓ **Promote collaboration, learning and exchange** within and between nations, sectors, disciplines and groups of society for the collective generation of knowledge and solutions and to promote equitable access to current and future technologies and tools.
- ✓ Take stock of existing cross-sectoral global and regional initiatives around One Health, identify and advise on synergies and overlaps, and support coordination.
- ✓ Mobilize and make better use of resources across sectors, disciplines and stakeholders.

# Action track 1: Enhancing One Health capacities to strengthen health systems

- √ 1.1. Establish the foundations for One Health capacities
- ✓ 1.2. Generate mechanisms, tools and capacities to establish a One Health competent workforce and the frameworks/processes to facilitate One Health work

✓ 1.3. Generate an enabling environment for the effective implementation of One Health



# Action track 2: Reducing the risks from emerging and re – emerging zoonotic epidemics and pandemics

- 2.1 . Understand the drivers of emergence , spillover and spread of zoonotic Pathogens
- 2.2. Identify and prioritize targeted, evidence based upstream interventions to prevent the emergence, spillover and spread of zoonotic pathogens
- 2.3. Strengthen national, regional and global One Health surveillance, early warning and response systems



# Action track 3: Controlling and eliminating endemic zoonotic, neglected tropical and vector-borne diseases

- 3.1. Enable countries to develop and implement community- centric and risk- based solutions to endemic zoonotic, neglected tropical and vector- borne disease control using a One Health approach involving all relevant stakeholders.
- 3.2. Ensure the harmonized application of One Health principles at all levels by implementing practical measures to Strengthen local, national, regional And global policy frameworks for the control And prevention of endemic zoonotic, neglected tropical and vector-borne diseases.
- 3.3. Increase political commitment and investment in the control of endemic zoonotic, neglected tropical and vector-borne diseases, by advocating for and demonstrating the value of a One Health approach.



# Action track 4: Strengthening the assessment, management and communication of food safety risks

- 4.1 . Strengthen the One Health approach in national food control systems and food safety coordination
- 4.2. Utilize and improve food systems data and analysis, scientific evidence and risk assessment in developing policy and making integrated risk management decisions
- 4.3 . Foster the adoption of the One Health approach in national foodborne disease surveillance systems and research for the detection and monitoring of foodborne disease and food contamination



### Action track 5: Curbing the silent pandemic of AMR

- 5.1. Strengthen the capacity and knowledge of countries to prioritize and implement context-specific collaborative One Health work to control AMR in policy, legislation and practice
- 5.2 . Reinforce global and regional initiatives and programmes to influence and support One Health responses to AMR
- 5.3. Strengthen global AMR governance structures.




### Action track 6: Integrating the environment into One Health

- 6.1 . Protect, restore and prevent the degradation of ecosystems and the wider environment
- 6.2. Mainstream the health of the environment and ecosystems into the One Health approach
- 6.3 . Integrate environmental knowledge , data and evidence into One Health decision- making
- 6.4. Create an interoperable One Health academic and in-service training programmes for environmental, medical, agricultural and veterinary sector professionals

### 5 steps to implement OH JPA

- 1. Situation analysis
- 2. Set-up a coordination mechanism
- 3. Planning for implementation
- 4. Implement national OH action plans
- 5. Review, sharing and incorporation of lessons learned

#### Set-up/strengthening of One Health governance and coordination

2.1 Establish or strengthen a sustainable national One Health governance approach through a multisectoral One Health coordination mechanism





#### Review, sharing and incorporation of lessons learned

5.1 Incorporate lessons learned from implementation activities through MEL, prepare annual reports on progress of national One Health workplans, and share lessons learned and best practices to scale results



#### Planning for implementation

- 3.1 Identify, adapt and develop activities based on the three pathways of the theory of change, linking to the action tracks and existing national action plans
- 3.2 Prioritize activities based on strategic objectives and criteria
- 3.3 Review, develop and/or adapt a costed and prioritized national One Health action plan, linking to existing national plans
- 3.4 Analyse the resource environment/investment landscape and develop a One Health investment strategy
- 3.5 Develop and adapt a monitoring, evaluation and learning (MEL) framework at national level



#### Implementation of national One Health action plans

4.1 Follow through on activities and MEL according to the three pathways of the theory of change, reviewing and adapting priorities to each context
