Recommendations:

- Adopt a One Health approach to address the interconnectedness of human, animal, and environmental health



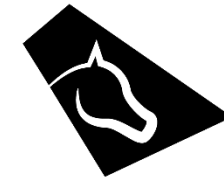

- Promote the use of Artificial Intelligence to support veterinary services in prevention, prediction and control of TADs;
- REMESA countries should make use of existing tools and resources to improve rabies surveillance (including data collection, reporting, and cross-sectoral data sharing) and to implement national strategic plans;
- REMESA countries should monitor and evaluate progress towards 'Zero by 30' in line with the Global Strategic Plan and M&E framework, including submission for relevant international milestones. The REMESA Secretariat should support countries in applying for these milestones.

Mers Cov Vaccine Use Case Webinar

18-19 November 2025

One Health session, convened by CEPI in collaboration with FAO, WHO and WOA, to take first steps to explore the feasibility, cost-effectiveness, and public health value of vaccinating dromedary camels against Middle East respiratory syndrome coronavirus (MERS-CoV) to prevent spillover to humans.

Objectives

1. Assess impact, feasibility, and cost-effectiveness of dromedary camel vaccination as a public health measure to prevent MERS-CoV spillover to humans.
2. Identify current knowledge gaps and prioritize data needs to inform a future, comprehensive workshop on the camel vaccination use case.
3. Engage cross-sectoral stakeholders (public health, veterinary health, academia, regulators, and funders) in a One Health dialogue to align perspectives and next steps.
