

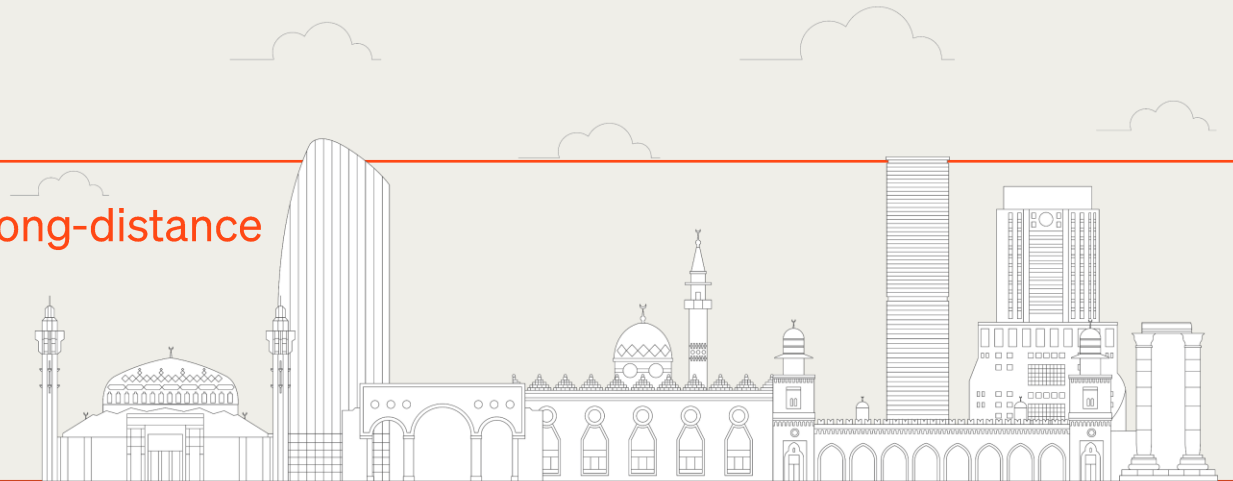

Overview of country livestock transport and trade

- Germany exports mainly cattle for breeding, non for slaughter
- TV documentary in November 2017 showed that EU legislation on animal welfare during transport was not complied with in many non-EU countries of destination, in some not even WOAHA standards
- stronger controls in DE → are EU legislation and verdict C-424/13 of European Court of Justice really complied with?
- significant reduction of number of exports (from 95,000 bovines in 2017 to less than 4,000 in 2025)
- for animal welfare reasons, Germany does not support long distance transports to far away countries and as a consequence has drawn back bilateral agreed veterinary health certificates in July 2023 for breeding ruminants

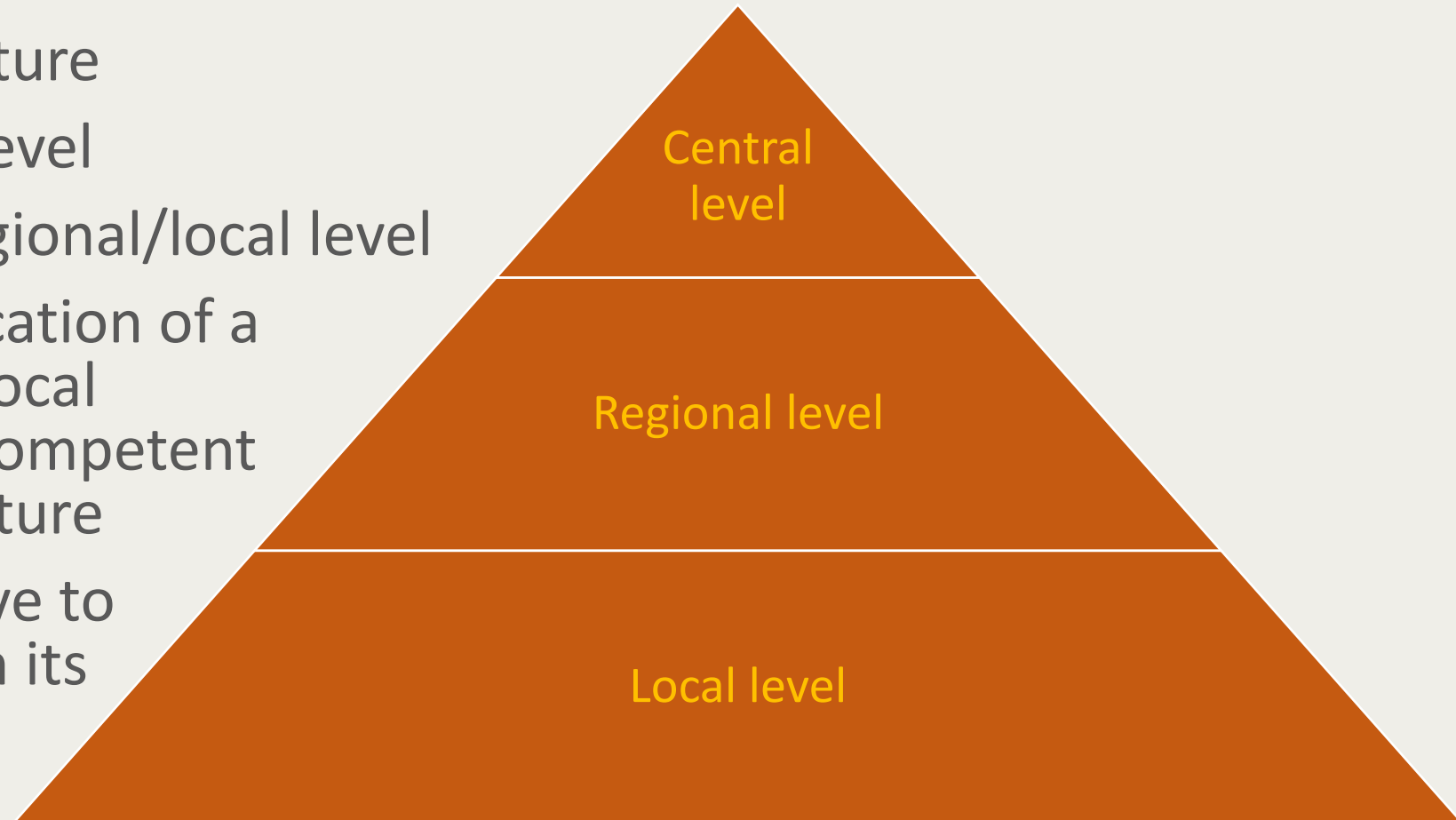

Competent Authority(ies)

- DE has a federal structure
- legislation at central level
- implementation at regional/local level
- decision about certification of a transport is with the local veterinary authority competent for the place of departure
- this authority may have to consider decrees from its regional authority





National animal welfare standards

- Germany follows EU plus national legislation (e.g. on temperatures)
- <https://www.fli.de/de/service/handbuecher-der-ag-tierschutz-der-lav/> → “Handbuch Tiertransporte” (interpretation of legislation)
- long, with multiple annexes, in German, regularly revised
- e.g. on performance of official controls (before, during and after the journey), standards of facilities/ vehicles, competence of drivers etc.
- example 1: in case of exports, the certifying authority at the place of departure must always be present during loading
- example 2: the competent authority requests online access to the GPS data of the transport vehicle (signal does not end at EU border)



Implementation of the standards

- competent authority looks at compliance with EU legislation (Regulation 1/2005)
- requirements of Regulation (EU) 1/2005 in line with WOH standards
- therefore, WOH standards are automatically implemented in DE



Monitoring and evaluation

Local authority competent for place of departure:

1. checks before the journey: Does the planning suggest that the journey will be carried out in compliance with EU AW legislation?
 2. checks during certification: presence during loading of exports
 3. checks en-route: online access to GPS data
 4. retrospective checks: Are entries in Journey Log, GPS data and temperature recordings plausible? Are they in compliance with Reg 1/2005? And are they in line with the planning?
- result of all these checks can be considered in case of future application for another export



Monitoring and evaluation

Local authority competent for a place along the route:

- authorities at control posts/ exit point (or at road-side checks)

Local authority competent for transporter:

- evaluation of previous performance (either during audits, or when the renewal of the transporter authorisation is applied for)



Cross-border transport of animals

Procedures:

- refer to Handbook

Non-compliances:

- entry in TRACES and additionally (more detailed) in an EU database named iRASFF (Animal Welfare Network – AWN)
- aim: information exchange, works very well within EU
- so far few attempts for information exchange with non-EU countries
- in most cases worked really well, very beneficial, in one case no reply



Weaknesses/ Challenges

- case of pregnant DE heifers rejected at TR border (16 Sep - 15 Oct 2024)
- similar cases occur repeatedly involving various countries (both road and sea journeys)
- these cases result in severe animal suffering and are a very stressful situation for everyone involved
- communication is essential to effectively help the animals and to have knowledge about the decisions taken and why
- good to have workshops like this one (to get into contact and to build trust)



Weaknesses/ Challenges

Most important questions:

How can such events be avoided?

(e.g. pre-arrival certification of documents)

What can be done if such events occur?

(unloading, provision of food, water, bedding and veterinary care)



Conclusions

- Animals are sentient beings and cannot be treated like other goods.
- WOAHA standards and requirements of EU legislation form the basis for DEs actions.
- DE wishes for harmonized implementation of common requirements and WOAHA standards across all countries.
- Compliance along entire route is the responsibility of ALL competent authorities.



Conclusions

Unexpected events can always occur:

- There should be procedures in place to avoid border rejections.
- There should be procedures in place to maintain animal welfare during the event of border rejection.
- A functional, trustful exchange of information is essential.
