Resolution No. XIV from the 70th WOAAH General Session, 26 - 31 May 2002

- Animal welfare has been identified as a strategic priority for the WOAAH since 2001, under the mandate granted by all Members.

Resolution No. XXXI from 85th General Session, 21–26 May 2017

- The WOAAH Global Animal Welfare Strategy was developed from lessons learned from actions taken at national and regional level and aims to be a source of ongoing guidance for the WOAAH's activities in this area, and it's based in four main pillars.



VISION

A world where the welfare of animals is respected, promoted and advanced, in ways that complement the pursuit of animal health, human well-being, socio-economic development and environmental sustainability.

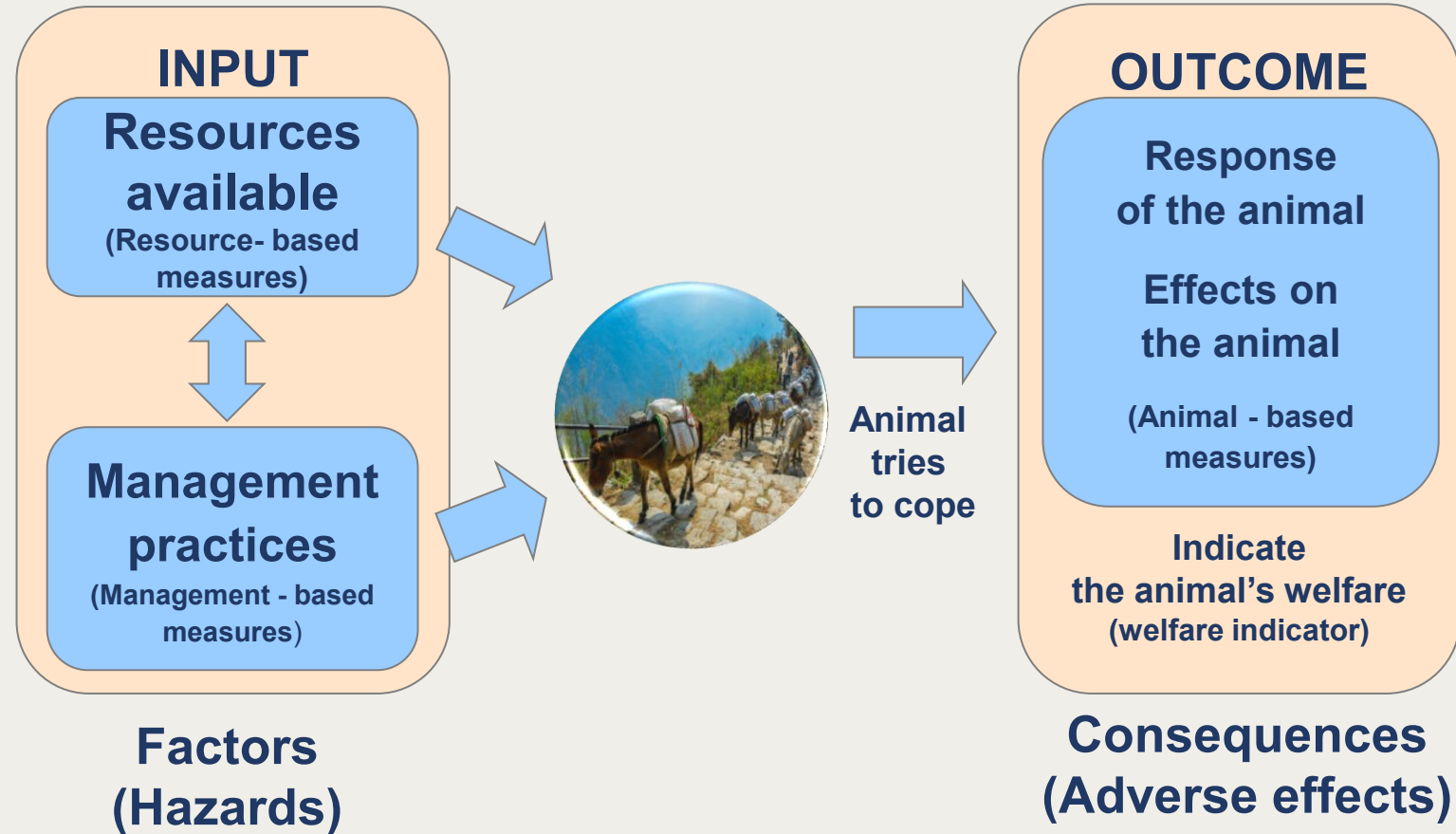

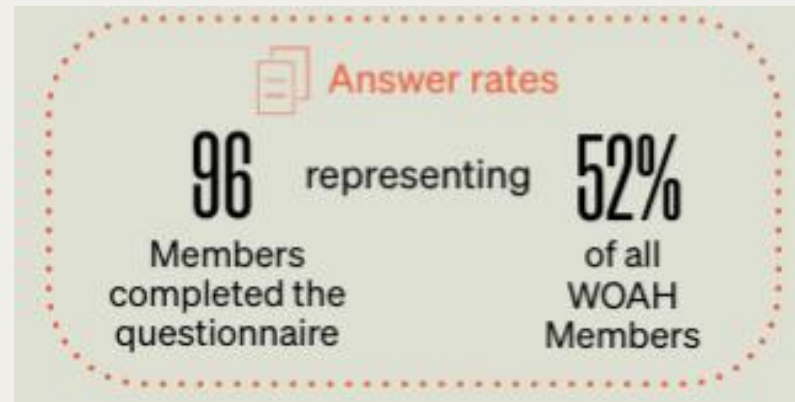

THEMATIC STUDY - ANIMAL WELFARE DURING TRANSPORT



The WOAAH Observatory, together with WOAAH Standards Department, is conducting a two-step study: step 1 to assess the level of implementation of WOAAH standards related to animal welfare during transport by land and sea via a worldwide survey (finished), step 2 to explore the barriers to the uptake of these standards via focus group discussions.

A majority of Veterinary Authorities have a regulatory framework in place...

Among the respondents reporting transport



by land



78%

reported having a regulatory framework in place covering animal welfare during transport



by sea



70%

Most Veterinary Authorities have an enforcement mechanism...

Among the respondents who reported having a regulatory framework in place covering animal welfare during transport



by land



72%

reported having a mechanism in place to enforce the regulatory requirements related to animal welfare during transport



by sea



74%

More than 80% of respondents reported having specific requirements in place for vehicles and vessels. This percentage, however, was found much lower for holding facilities and containers (around 60% of responding Members). Responsibility and specific requirements of actors involved in transport operations were not always defined.

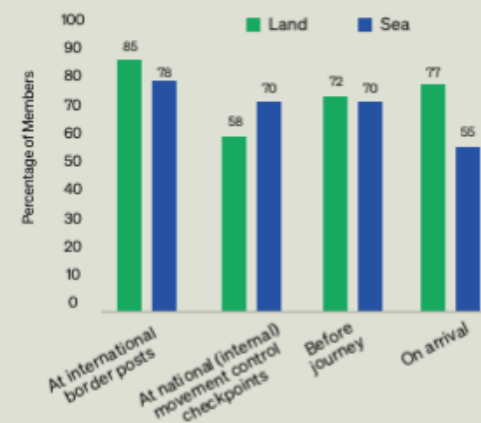

* Journey duration and space allowance were the requirements more frequently reported as having to be part of the journey plan. The less reported requirements were weather and road conditions.
