

Renewal of the Regional Steering Committee (RSC)

The GF-TADs in Middle East was established in 2006

The RSC 6 was held in September 2013

The RSC7 was held in october 2020 virtually

- Confirmed the relevance of the GF-TADs coordination mechanism for the region and revitalised momentum
- Renewed chairmanship and members
- Revised the Terms of Reference of regional steering committee and regional secretarariat, now harmonised with other regions
- Support addressing certain activities at sub-regional levels
- Recognize the importance to work with the private sector
- Reviewed the priority TADs for the region


The Regional Steering Committee in link with the Global level and other regions

The new GF-TADs Strategy 2021-2025 was launched on 2/11/21 at the occasion of the GSC 12


The regional action plan for Middle East will directly contribute to it – the global level will provide all possible support

PPR

- Reach stage 3 of PPR PMAT
- Relevant Epi/lab networks established

RVF

- RVF status assessed and mapped
- Establishment of an active Early Warning System
- Laboratory competency diagnostic capacity improved
- OIE relevant standards implemented by trading partners


Rabies

- Human deaths from dog mediated rabies reduced
- Potential official control program submitted to the OIE (in the next 3 years)

Conclusion

Support from global level to specifically focuses on capacity development and advocating regional needs.

The One Health approach be reinforced and used to benefit the control of TADs.

The GF-TADs resource mobilisation strategy be developed using a programmatic approach targeting cross-cutting, national needs.

Stronger involvement of the private sector in GF-TADs needs to be promoted.

The key of sucess will be the engagement of countries in control of priority TADs and indicating their needs to receive targetd support

- → Ensure there is follow-up at the level of your veterinary services and parnters
- → for FMD and PPR Regional Advisory Groups (RAGs) can play a significant pivot role
