

Facilitate

Facilitate collaboration

Maximize synergies among the countries, organisations and stakeholders in the region

Good visibility of actions and avoid overlapping of activities.

Prevent

Prevent the occurrence and reduce potential impact of animal disease events on animal production, animal health, human health, livelihoods and economies in the region.

Ensure

Ensure the appropriate auditing of the plan efficacy and evaluation of expected results

Main activities

Facilitate regional and cross-border collaboration in the field of control of animal health and trade requirements, including networking activities.

Raising awareness and improve knowledge and sharing of information/data;

Improve reporting and outreach communication on activities carried out by the different partners.

Provide technical guidance to improve disease prevention, surveillance, early detection, notification and rapid response systems.

Improve diagnostic laboratory capacity and performance at national level and support the establishment / reinforcement of national and regional reference laboratories, including laboratory networks.

Specific activities

FMD and PPR: Sub region, Countries or zones, be at least on stage 3 of the FMD PCP Roadmap and the PPR PMAT within the next 5 years, and the relevant Epi/lab networks established.

RVF: Assessment and mapping of RVF status. Establishment of an active EWS for the prevention and prediction of RVFV activity. Improvement of laboratory competency for the diagnosis of RVF, and implementation of OIE standards for RVF by trading partners.

Rabies: Reduction of human deaths from dog mediated rabies in the next 5 years, and potential submission to the OIE of the official control program in the next 3 years.



- ▶ Measures to enforce implementation of standards for safer trade.
- Lack of funds for the purchase or production of appropriate vaccines and diagnostic kits.
- Need for capacity building mainly on risk assessment and monitoring.
- More political commitment in particular to obtain sustainable financing.
- ▶ More engagement of stakeholders from private sector.

Conclusion and recommendations

- Tackling diseases at the animal source remains the most efficient and cost-effective way of dealing with zoonotic threats and high impact disease.
- Support from global level to specifically focuses on capacity development and advocating regional needs.
- The One Health approach be reinforced and used to benefit the control of TADs.
- The GF-TADs resource mobilization strategy be developed using a programmatic approach targeting cross-cutting, national needs.
- Stronger involvement of the private sector in GF-TADs should be promoted.
